

The Honorable Earl B. Gilliam

1931 - 2001

arl B. Gilliam received his Bachelor of Arts degree from San Diego State College in 1953 and graduated from Hastings College of Law in San Francisco in 1957. That same year he began his legal career as a Deputy District Attorney in the San Diego District Attorney Office.

In 1961, he went into private practice and continued in that capacity for two years before becoming a San Diego Municipal Court judge in 1963. He subsequently became the first African American to serve as a San Diego County Superior Court judge in 1975. In 1980, President Jimmy Carter appointed him as judge of the United States District Court, Southern District of California. In 1993, Judge Gilliam attained senior status at the United States District Court.

Judge Gilliam was the first African American U.S. District Court Judge for the Southern District of California and the first African American San Diego County Superior Court judge.

Due to his many contributions to the legal community and community at large, Judge Gilliam was honored with more than a dozen awards during his legal career, including, but not limited to, the following: San Diego Chamber of Commerce Young Man of the Year (1965); San Diego Citizen of the Year (1973 and 1994); San Diego Good Guy Award (1974); Boy's Club of San Diego Golden Man of the Year (1981); San Diego Trial Lawyers Association Trial Judge of the Year (1981); and a place on the San Diego High School Wall of Honor (1994).

Judge Gilliam's community and civic activities included participation in the following organizations: Kappa Alpha Psi Fraternity; Sigma Pi Phi Fraternity (Founding Member); Founder and Organizer, Black Jewish Dialogue; Chairman, Legal Committee of the NAACP; Board of Directors and Vice President YMCA; and Advisory Committees for the Board of Education on Equal Education. Additionally, Judge Gilliam served as a member of the Board of Directors for numerous organizations including the following: Villa View Hospital Foundation; San Diego Kind Corporation; Burn Institute; San Diego State University Alumni Association; Salvation Army; YMCA; Urban League; Navy League; the Burn Institute of San Diego; and 200th Anniversary of the City of San Diego. Judge Gilliam was also awared the National Bar Association's Wiley A. Branton Award (1997) and the California Association of Black Lawyers' Judicial Pioneer Award (1998). Judge Gilliam was also inducted into the National Bar Association Hall of Fame, which honors lawyers who have been licensed to practice for forty years or more and have made a significant contribution to the cause of justice.

In 1982, the Association of Black Attorneys of San Diego County (initially founded in 1976) changed its name to the Earl B. Gilliam Bar Association in honor of Judge Gilliam. Today, the Earl B. Gilliam Bar Association represents the interests of African American lawyers, judges, law professors and students throughout San Diego County and strives to honor Judge Gilliam's legacy of community service.


James Weldon Johnson

ouglas A. Oden is a native of San Diego growing up in Southeast San Diego. He graduated from San Diego High School in 1968 and completed his undergraduate work at California Lutheran University with a B.A. degree in Political Science.

Mr. Oden credits the late Honorable Earl B. Gilliam with helping him succeed in law school. Mr. Oden graduated from Western State University College of Law in San Diego now known as Thomas Jefferson School of Law in 1977 in 1978. He started his own firm in 1978 and remains in private practice. Mr. Oden has always practiced both criminal and civil law. In the criminal arena, he has defended individuals charged with crimes from theft to attempted murder. He has developed a successful personal injury practice obtaining settle-

ments and judgments for his clients ranging from a few thousand to over a half million dollars. Mr. Oden is currently the Senior Litigation attorney with the law firm of ODEN &GREENE. The firm's areas of practice include civil litigation, bankruptcy, criminal law, and personal injury.

Mr. Oden has been very active in the legal community on the local, state and national level. He is a former President of the Earl B. Gilliam Bar Association and a Past President of the California Association of Black Lawyers. He is a former Lawyer Representative to the Ninth Circuit Judicial Conference and has served on the Executive Board of the State Bar Solo and Small Firm Section.

Mr. Oden is also active in community affairs. He has served as Vice Chairman of the Southeastern Economic Development Corporation and is the immediate Past President of the San Diego Branch of the NAACP. He is the recipient of numerous awards including the Loren Miller Award from the San Diego Branch NAACP, the Career Achievement Award from California Lutheran University, twice selected as a recipient of the Thurgood Marshall Award and the Distinguish Service Award from the Earl B. Gilliam Bar Association. He has also received Resolutions from the City and County of San Diego and the California State Assembly and the California Senate.

Jock Smith, Keynote Speaker



"When I started my first national law firm for civil justice, the first lawyer I selected was Jock Smith."

Jock is a distinguished trial lawyer and recognized as one of America's top civil litigators. President, founder, and senior partner of one of America's largest plaintiffs' law firms, The Cochran Firm, Jock practices law across the United States in the areas of civil litigation. For the past 29 years, Jock has specialized his practice to cases in the areas of automobile negligence, products liability, fraud, nursing home abuse, mass torts, class actions, general plaintiffs' tort liability claims and wrongful death.

In July of 1998, Jock Smith became national law partner to "Super Lawyer" the late Johnnie L. Cochran, Jr. as a founder and senior partner in the national law firm Cochran, Cherry, Givens & Smith, with offices in Tuskegee, Alabama, Los Angeles, New York, Chicago, Memphis, Atlanta, Washington D.C., St. Louis, Las Vegas, New Orleans, Miami, Jackson, Dallas, Birmingham and Dothan, Alabama.

Jock was influenced early in life to become a lawyer just like his father Jacob Smith, a prominent attorney and civil rights and political leader who represented entertainment giants, the likes of Count Basie and national organizations such as the NAACP. Jock earned his law degree from the University of Notre Dame Law School in 1973 after graduating with honors from Tuskegee University with a Bachelor of Science degree in history.

Jock has enjoyed a storied legal career serving as President of the Alabama Lawyers Association as well as the Macon County Bar Association. He also has served as a municipal judge in the State of Alabama as well as an administrative law judge for the Alabama Department of Environmental Management. Jock not only serves on the Executive Committee of the Alabama Trial Lawyers Association but also served as a Trial Trustee, the first African American to do so. He also has established himself as one of the most sought after speakers at legal seminars. Smith is a member of the American Bar Association and the Association of Trial Lawyers of America. In addition, he is a member of the Alabama Bar, Tennessee Bar, District of Columbia Bar, Missouri Bar and the New York Bar.

Throughout his career, Jock has obtained numerous record multi-million dollar verdicts in civil cases. On August 18, 2000, he obtained a verdict of 80 million dollars (\$80,000.000.00) in the case Jeter v. Orkin for an elderly black female whose house was destroyed by termites after she was defrauded by the company. Recently, Jock received a record \$1.62 billion dollar verdict (\$1,620,000,000.00) in the case Whittaker-v. Southwestern Life Insurance Company, et al. for plaintiff Whittaker, a 50 something mother of three who was a victim of fraud arising out of the sale

and service of what she thought was a legitimate insurance policy that later proved to be nonexistent. This verdict was reported as the single largest verdict in the nation in the National Law Journal and the U.S. Lawyers Weekly for the year 2004. This verdict was reported and published in 350 newspapers and magazines nationwide including Jet magazine, Black Enterprise magazine, the Atlanta Journal Constitution and New York Times. Martindale-Hubbell has given Smith its highest rating, the AV Rating, and in May of 2006, Lawdragon Legal Magazine in Los Angeles, California selected Jock as one of America's Top 500 Trial Litigators.

In 2002, New South Books published Jock's autobiography entitled, "Climbing Jacob's Ladder: A Trial Lawyer's Journey on Behalf of the Least of These". A sought after talk-show guest, Jock has appeared on numerous national television and radio programs including, "The Tavis Smiley Show," which airs on National Public Television, "The Bev Smith Show," airing on The American Urban Radio Network, Al Sharpton's "Keeping It Real" radio program that airs on News Talk 1200 WHCB AM and "The Michael Eric Dyson Show" which airs on the same network, "The Ed Gordon Show," of National Public Radio, "Praise the Lord", which is broadcast on the Trinity Broadcast Network, and "The 700 Club," airing on the Christian Broadcast Network.

Jock has received numerous awards among which include an Honorary Doctor of Divinity Degree by the Pentecostal Bible College, Tuskegee, Alabama; keys to the cities of New Orleans and Memphis; recognized by the Alabama Trial Lawyers Association for tireless dedication and unwavering commitment; inducted onto the Million Dollar Advocates Forum and received the Inaugural Johnnie L. Cochran, Jr. Journey to Justice Award in 2005 at the National Bar Association Convention.

Partly due to having a long history and commitment to championing environmental issues, Smith was inducted onto the President's Advisory Council of the National Wildlife Federation (NWF), making him the first African American to serve on that board. Founded in 1936 by President Franklin Roosevelt, the NWF has been instrumental in exposing cases of environmental injustice throughout the world.

Jock is a 20-year active member of Christian Life Church in Montgomery, Alabama. He is married to Yvette Smiley-Smith, Managing Principal of Smiley-Smith and Bright, CPA's, specializing in forensic accounting and expert witness testimony in civil litigation across the United States. Their daughter, Janay, is attending law school at Cumberland Law School in Birmingham, Alabama. Jock is dedicated to helping people who have been injured to obtain justice and fair compensation.

Middleton is a current member of the San Diego County Bar Association and Consumer Attorneys of San Diego. She is a past board

member and Southern District Representative for California Association of Black Attorneys. Prior to her current position as President-Elect of the Earl B. Gilliam Bar Association, Middleton served in the positions of Treasurer and Member At Large.

In 2006, Middleton received the Distinguished Service Award from the Earl B. Gilliam Bar Association in recognition of outstanding service and dedication. In 2007 she was a recipient of the State Bar of California's Wiley M. Manuel Award for volunteering more that 50 hours of service to Legal Aid Society of San Diego.

Middleton is committed to community service and has served as both a Board Member and President of Our Place Center of Self Esteem, a non profit community organization. The primary mission of Our Place is to increase self esteem in children, especially girls and to reduce domestic violence.

History of the Earl B. Gilliam Bar Association

The Earl B. Gilliam Bar Association was originally established in 1976 as the Association of Black Attorneys of San Diego County. In 1982, under the presidency of Daniel Weber, the organization changed its name to the Earl B. Gilliam Bar Association ("EBGBA") in recognition of Honorable Earl B. Gilliam, the first African-American United States District Court judge for the Southern District of California. Judge Gilliam was also the first African-American to serve as a San Diego County Superior Court judge.

Today, EBGBA represents the interests of African-American attorney, judges, law professors and students in the county of San Diego. The non-profit organization's mission statement articulates its commitment to "defending the legal and hum rights of African-American; eliminating the root causes of proverty, powerlessness and racism; preserving the high standards of integrity, honor and courtesy in the legal profession; and promoting the professional and personal interests of individual members."

The EBGBA includes present and former judges, professors and officers of the National Bar Association, National Association for the Advancement of Colored People, the California Association of Black Lawyers, the San Diego County Bar Association and the Lawyers Club of San Diego. Many continue to serve in leadership positions on boards and committees of the State Bar of California and other organizations.

EBGBA, through its members, makes positive contributions to the community of San Diego bar participating in San Diego's annual Martin Luther King, Jr. parade, operating a Neighborhood Law School, organizing public forums and seminars, hosting annual Juneteenth Celebrations, and other activities. In addition to its activities in the community, EB-GBA is committed to encouraging law student achievement by awarding scholarships, establishing mentor-mentee programs, and hosting annual law student mixers.

Shirley N. Weber, Ph.D.

Shirley N. Weber attended UCLA where she received her B.A., M.A. and Ph.D. by the age of 26. She graduated from UCLA as an undergraduate she was one of 12 Woodrow Wilson Fellows in a class of over 6,000. At the age of 23 she became a professor at San Diego State University where she helped develop the department of Africana Studies.

In 1988, she was elected to the Board of Education of San Diego City Schools. While a member of the Board, unprecedented progress was made in student achievement level in poor communities.

Dr. Weber is recognized nationally and internationally for her ground breaking work to establish the discipline of Africana Studies. She has authored numerous articles and chapters in books on Marcus Garvey, Black Nationalism and Black Studies. From 2002-2006 she served as president of the largest international organization of professionals in the field of Africana Studies, the National Council for Black Studies. She also chaired the department of Africana Studies at San Diego State University for over fifteen years. She has been selected Outstanding Faculty seven times, and was selected Outstanding Young Woman in America twice. She is the originator of the successful, SDSU Black Baccalaureate Service (1980-present).

Dr. Weber is Director of the Academy for Effectively Teaching African American Students. This academy re-trains current teachers in Southern California on effective tools for teaching African American students. Dr. Weber is also the Executive Director of the Association for African American Educators in Southern California. She is the co-founder and Director of the W.E.B. DuBois Leadership Institute for Young Black Scholars through the NAACP, and co-Director of a Summer Institute in Ghana at the University of Lagon.

Dr. Weber annually takes a group of students to South Africa to volunteer with AIDS projects and at various youth centers and schools. For her humanitarian work, Dr. Weber has received hundreds of awards from a wide range of organizations (NAACP, Urban League, ACLU, Women's International, YMCA, National Sorority of Phi Delta Kappa, Inc, etc.) too numerous to name. 2006, Dr. Weber was appointed to the Board of Directors of Southwestern Christian College, an HBCU in Terrell, Texas. In 2009, she was selected as the SDSU's Top 25 honored by President Stephen Weber.

Dr. Weber lectures widely throughout the United States, Caribbean and Africa. She is a regular speaker at various Christian Women lectureships throughout the United States. She currently serves at the mayor's appointee and Vice Chair on the Citizens' Equal Opportunity Commission.



Robert Fikes Jr.

Born in Birmingham, Alabama, and a first-hand witness to events that occurred during the turbulent era of civil rights protests, Robert Fikes Jr. graduated from Tuskegee University in 1970 and obtained graduate degrees in modern European history and library science at the University of Minnesota. He has spent the past 32 years as a reference librarian at San Diego State University.

His first published article, "Jose de Acosta's Window on the New World," appeared Americas in 1976 and was translated and published in the magazines Spanish and Portuguese editions. Among several of his monographs is Racist and Sexist Quotations (1992) which can be found in the reference book section of major American libraries, and two online books pertaining to the history of SDSU. Robert has published hundreds of items in books, journals, magazines, and newspapers (among them the Oxford Companion the African American Literature, The Historical Encyclopedia of World Slavery, American National Biography, W.E.B. Du Bois: An Encyclopedia, The Greenwood Encyclopedia of African American Civil Rights, Crisis, Journal of Ethnic Studies, San Diego Voice & Viewpoint, La Prensa San Diego, Los Angeles Sentinel, Callaloo, Western Historical Quarterly, California History, Western Journal of Black Studies, Connecticut Review, San Diego Union, Journal of Negro Education, Negro History Bulletin, Journal of Blacks in Higher Education, Afro-Hispanic

Review, Black Art, College & Research Libraries, Library Journal, Negro History Bulletin, CLA Journal, Journal of the National Medical Association, Obsidian, Presence Africaine, Daily Californian) and he has authored numerous online pieces for BlackPast.org., AfrocentriNews.com, Inmotionmagazine.com, websites of the NAACP, etc. From 1978 to 2002 he was editor of the quarterly newsletter CBFSA News, the official organ of the California Black Faculty and Staff Association. His 24-page research paper on colonial troops in Europe during World War I resides in the collections of the Imperial War Museum in London, the U.S. Military Academy at West Point, and the U.S. Army Military History Institute in Pennsylvania); and a 19-page translation and commentary on a document pertaining the rebellion of the petitsblancs in Haiti in 1790 is in Benson Latin American Collection at the University of Texas at Austin.

Robert has appeared several times on KPBS radio and television and most recently was interviewed for a segment on the evening news of KNSD-TV Channel 7/39. In 2007 he earned one of SDSU's highest honors, the "Monty," awarded by SDSU Alumni Association to outstanding faculty. He is also the recipient of the 2004 Unsung Hero Award presented by SDSU's African Studies department and, in 2008, received a recognition memento from SDSU's War Memorial Committee for his research on the school's 221 students killed while serving in the military. He attended University of San Diego School of Law graduating in 1971. Judge Jones served as a San Diego Municipal Court from 1977 to 1982 and Superior Court Judge from 1982 to 1994. On

June 8, 1994, President Bill Clinton nominated Judge Jones the United States District Court for the Southern District of California to fill the seat vacated by Earl B. Gilliam.

He obtained his law degree from Howard University School of Law and commenced his legal career as a Deputy Attorney General in the California Attorney General's Office in the Natural Resources Section. He was the first African American Supervising Deputy Attorney General in San Diego, supervising the Employment, Regulation and Administration Section. He currently serves as a Deputy Attorney General in the Attorney General's Consumer Law Section.

Dennis maintains active status in the United States Coast Guard Auxiliary, is the leader of the Dennis Dawson Jazz Ensemble, and is a musician with Christ the

King Gospel Choir. He is a member of Howard University Alumni Association, a Board member of the Mountain View Tennis and Racquet Club, and a life member of the NAACP and Alpha Phi Alpha Fraternity.

The Honorable Joe O. Littlejohn, Retired Superior Court

he Honorable Joe Littlejohn graduated from the University of San Diego School of Law in 1972. In 1979, Judge Earl B. Gilliam asked encouraged Judge LIttlejohn to seek a judicial appointment. He declined because he had already committed to run for a seat on the San Diego Unified school board. Out of respect for his mentor and despite winning the election, Judge Littlejohn completed a judicial application. In April 1981, Judge Littlejohn was appointed to the Municipal Court. In 1994, Judge Littlejohn was elected to the Superior Court.

Judge Littlejohn's philosophy is expressed in a much-quoted Chinese proverb: "If you plan for a year, plant rice. If you plan for 10 years, plant trees. If you plan for 100 years, educate kids." Judge Littlejohn retired in April 2006.

The Honorable Ernestine Douglas Littlejohn - Administrative Law Judge, Ret.

n 1974, Ernestine Douglass Littlejohn was the first African American woman to graduate from the University of San Diego School of Law. Her other firsts include: the first African American Deputy County Counsel for San Diego County and the first African American Deputy Schools Attorney for the San Diego Unified School District. Judge Littlejohn became an Administrative Law Judge for the California Unemployment Insurance Appeals Board in

1982, retiring in 2004.



The numerous awards she has received include: The Salvation Army Woman of Distinction Award, the Women Inc Award, Mother of the Year Award and the Earl B. Gilliam Bar Association Distinguished Service Award.
